I further confirm as follows:

- 1) I will undertake the Erasmus+ Mobility at my own responsibility and my own risk.
- 2) The decision whether a mobility can be started despite an existing travel advice from the Ministry of Foreign Affairs is the joint responsibility of the sending institution and the Erasmus+ participant. I therefore commit myself to contact the Erasmus Coordinator of my home university before starting my Erasmus+ Mobility, to clarify the current situation and to follow any instructions of my home university regarding the feasibility of the mobility.
- 3) Due to the current pandemic, Erasmus+ Study Mobilities as well as Erasmus+ Internships can be started virtually. The aim is that the virtual stay is followed by a physical stay on site. If possible, the physical stay at the host institution should correspond to the minimum duration for study (3 months) or internship (2 months) stays. However, the Erasmus+ grant can only be awarded for a physical stay at the host institution. No grant can be awarded for stays completed entirely in the form of e-learning or teleworking from the home country.
- 4) I acknowledge that - in the event of a premature termination of my mobility - I cannot claim any additional costs from the National Agency and/or the ABPU. It is my sole responsibility to ensure, independently and in due time, that I have sufficient insurance cover for the duration and scope of my travels and Erasmus+ mobility. I am advised to book my trip at short notice and carefully observe the cancellation conditions applicable at the time.

- 5) I will keep myself informed about the current situation regarding CoViD-19 both in the host country and in Austria (e.g. on the websites of the home university¹ and host institution, the National Agency², the Austrian Foreign Ministry³, concerned embassies, etc.).
- 6) I undertake to comply with all applicable national and international laws and regulations of the transit and host countries, in particular the laws and regulations (e.g. exit restrictions, distance rules, hygiene regulations, etc.) in connection with the CoViD-19 situation.
- 7) Upon completion of the mobility, I will inform myself about and comply with all applicable regulations regarding the crossing of the border into Austria and, if required, will undergo a two-week compulsory quarantine.
- 8) I take note of the explicit recommendation on travel registration⁴ – a service of the Austrian Foreign Ministry that is available to all Austrian citizens free of charge – and, if employable, carry it out myself.
- 9) In case of short-term travel warnings before departure, problems or uncertainties I will immediately contact my home university (Anton Bruckner Private University, Erasmus+ Coordination, E: noemi.parraghy@bruckneruni.at; T: +43732 701000 206) and/or the Erasmus Department of the OeAD (hochschulbildung@oead.at; T: +43 1 534 08-0*) to discuss my options (e.g. postponement of the mobility, delay of the journey, switch to e-learning, etc.) and coordinate the further course of action in accordance with the host institution.
- 10) I acknowledge that the Erasmus+ Mobility Grant is paid by the Erasmus Department OeAD⁵ and that the ABPU has no influence on whether or to what extent the mobility grant has to be refunded in case of discontinuation or interruption of the study visit. I understand the information about the current risks and dangers that may arise from CoViD-19 regarding the conditions of the Erasmus+ scholarship.
