Purposes and legal bases of data processing

Anton Bruckner Private University processes the personal data you have provided to the extent necessary to fulfil contractual obligations, namely to process the application for emergency assistance as defined in Art 6 Para. 1 lit b DSGVO. Without this data, we cannot conclude or execute the contract with you.

Transmission of the data

Your data will be transmitted to the bank for the transfer of the emergency aid to the extent necessary. If there is a legal obligation, the data must also be transmitted to authorities, courts and public bodies. In the course of legal disputes, personal data may also be transmitted to lawyers. In any event, your data will not be transferred to recipients in third countries.

Storage period

We process your data as long as it is necessary for the achievement of the purpose or as long as it is necessary for the fulfilment of the contractual obligations. In any case for the duration of the awarding of services from the Corona Emergency Fund. In addition, your personal data will be stored for the duration of your studies at the Anton Bruckner Private University.

Rights of the persons concerned

The data subject (i.e. the natural person whose personal data is being processed) has different - very comprehensive - rights vis-à-vis the person responsible (i.e. the organization, i.e. in this specific case Anton Bruckner Private University).

These rights serve the transparency of the processing of personal data. The data subject should be able to obtain information and should also know by whom, how, in what way, and why the data is being processed.

The data subjects have the following rights vis-à-vis the controller:

- Right to transparent information
- Right to information
- Right of rectification
- Right of cancellation
- Right to restrict processing
- Right to data transferability (only in case of contractual relationship or consent)
- Right of appeal to a supervisory authority.
